Finance plan change checklist

You will use this checklist within the **first 30 days** of switching from either Pay in 4 or Installments to Adaptive Checkout.

If you were previously on a Pay in 4 program, remove instances where interest-free/0% APR loans are the **only** examples mentioned on your website. Clarify that you offer loans at rates of 10-36% as well. Look closely at materials in all channels, including:

- FAQ and help center pages
- Financing options pages
- Banner and display ads
- Affirm-related landing pages
- Product/checkout pages
- Emails with messaging about Affirm or financing

Disclosures

Replace all instances of old disclosures with the following, adding information in where noted:

Rates from 0% APR or 10-36% APR. For example, an \$800 purchase might cost \$72.21/mo over 12 months at 15% APR. Payment options through Affirm are subject to an eligibility check, may not be available in all states, and are provided by these lending partners: affirm.com/lenders. Options depend on your purchase amount, and a down payment may be required. CA residents: Loans by Affirm Loan Services, LLC are made or arranged pursuant to a California Finance Lenders Law license.
